2020-2021 Tuition & Fees Information

Tuition is determined by the Diocese of Salt Lake in consultation with the Diocesan Schools Finance Committee.

Kindergarten through 8th Grade	\$7,990 (\$665.83/mo. for 12 months) + fees
Need-Based <u>minimum</u> (must qualify)**	\$3,567 (\$297.25/mo. for 12 months) + fees
International Tuition (<i>International Students w/visa</i>)	\$12,500 (\$1,041.67/mo. for 12 months) + fees

Early Childhood Program (price includes EDP and not eligible for tuition assistance)

Pre-Kindergarten Tuition (4 and 5 year olds)

(4 year olds; 5 HALF Days; Drop-off starting at 7:00am-11:30am*).....\$4,214 (\$351.17/mo. for 12 months) + fees

(4 year olds; 5 FULL Days; Drop-off starting at 7:00am-6:00pm*).....\$7,214 (\$601.17/mo. for 12 months) + fees

Preschool Tuition (3 and 4 year olds)

(3 year olds; 5 HALF Days; Drop-off starting at 7:00am-11:30am*).....\$4,418 (\$368.17/mo. for 12 months) + fees

(3 year olds; 5 FULL Days; Drop-off starting at 7:00am-6:00pm*).....\$8,150 (\$679.17/mo. for 12 months) + fees

*Class times for Early Childhood Program are 8:15am – 11:30am or 3:30pm.

Registration & General Fees

General Fees are due after acceptance, before the school year begins. (Fees are per student unless noted differently.)

Tuition

Saint Andrew Catholic School uses a tuition management system, FACTS, www.factsmgt.com, for all tuition collection. General fees and tuition will be added together and divided into 12 monthly payments beginning in June 2020 and ending in May 2021.

****Tuition Assistance**

Need-based tuition assistance is available for financial hardship for students in kindergarten through 8th grade. Applications are available online at www.factsmgt.com/AID . Completed financial assistance forms, a copy of your prior year Federal tax return 1040 or 1040A, and any additional supporting documentation must be submitted to FACTS Grant and Aid Assessment www.factsmgt.com/AID by March 20th. **APPLICATIONS FOR FINANCIAL ASSISTANCE MUST BE COMPLETED EACH AND EVERY YEAR.** All requested information is kept confidential. All required information must accompany the form or it will not be considered. The analysis and award process typically takes 5 business days. Upon completion of the analysis, each family will be contacted by email.
